## **WOMEN TO WATCH - 2024**

The National Museum has announced the focus for the next iteration of Women to Watch. The theme will explore artists' visions of a new world responding to the thematic question: "How have our societal conditions impacted artists' versions for the future or inspired them to create alternative current realities?" The exhibition will invite all media works including digital works. The announcement references several representative artists, including Wangechi Mutu, Debbie Grossman, Vibha Galhotra and Beatriz Cortez. The entrance fee will be \$10,000.

Arlene Finney, who so ably chaired the previous four local Women to Watch committees, will chair the committee for 2024 as well. As a first step, a curator to select women artists will be selected. The Curator will issue a call to women artists for submissions, and the process will begin. The next Women to Watch exhibition will open in the National Museum for Women in the Arts in galleries currently under renovation.

## **WOMEN TO WATCH UPDATE**

Two artists who submitted work for Women to Watch - 2015 ORGANIC MATTERS have been in the news recently. A large fabric work by *Sara Sonie'Joi Thompson-Ruffin* has been acquired by the Nelson-Atkins Museum of Art. "20 Odd" is a quilt roughly 4 x12 feet on which she worked for about 5 years. It was a part of an exhibition at the Carter Art Center titled "Journey: 400 Years 1619-2019" that Julian Zugazagoitia, Director and CEO of The Nelson-Atkins Museum of Art, saw when he led a group of museum members to view the exhibition. The Nelson-Atkins website describes the work as follows:

"In 1619 the crew of The White Lion brought 20 enslaved African people to the British colony Jamestown, Virginia. This marked the start of 250 years of slavery in North America. The 20 silhouetted figures in the center of this quilt are cut from different fabrics with African countries printed on them - a signal that although their individual identities have been lost, these men may not have all come from the same place." The second artist is Lara Shipley, whose photograph, "In the Ozarks There are Lights (Devil's Promenade)" was chosen for inclusion in the exhibition in Washington. The photograph is one of a series Shipley, and her collaborator, Antoine Dolezal, recently published as *Devil's Promenade*. Attempts to reach Shipley for further information were not successful.

#### **NEW DOCUMENTARY ON FRIDA KAHLO**

Is there room for another documentary about Frida Kahlo? Yes there is, especially when the documentary is produced by Phil Grabsky and directed by Ali Ray. The film is "Frida Kahlo" (2020). The two team up on a journey of extensive research into Kahlo's unusual life, following her trail in Mexico and Europe to turn over every leaf. Grabsky and Ray place Kahlo in the context of her time and of her relationships. They explain her choice of dress, the physical and emotional challenges in her life, and the motivations for her endless self-portraiture. Grabsky, who devotes himself to creating the best art films for the public, is known for 30 years of excellent documentaries including "Leonardo: The Works" (2019); Great Art Series; Exhibition on Screen: Young Picasso, and many more gems.
